Ecolution® Floor Stripper's heavy-duty formula is designed to remove Ecolution® High Solids Floor Finish and other non-metallic finishes. It does this without the harsh odors and fumes associated with conventional strippers.

### EFFECTIVE STRIPPING

Ecolution® Floor Stripper utilizes superior penetrating and emulsifying properties to quickly break down the floor finish. Ecolution® Floor Stripper is not formulated with 2-butoxyethanol, yet it safely removes finish from all types of floors, including asphalt tile, asphalt planking, rubber, vinyl tile and terrazzo. It's easily rinsed, leaving a clean and residue-free surface. It has no harsh odors and is ideal where strong ammonia or solvent odors are a problem.

### DIRECTIONS FOR USE

1. Dust mop or sweep surface.
2. Remove any stickers, decals, etc. with a putty knife.
3. Add one gallon of Ecolution® Floor Stripper to five gallons of cold water.
4. Apply stripper generously to work area (200-400sq. ft./gl).
5. Let the solution stand for 5-10 minutes. If necessary, reapply stripper to areas that dry quickly.
6. Use a black pad on a 175 rpm floor machine to scrub floor.
7. Pickup solution with a wet vac or mop.
8. Rinse with clean, cool water until all residue is removed.

Dispose of unused product in accordance with Federal, State and Local regulations. Use product in accordance with prescribed use dilutions. Empty containers can be recycled.
